

Terms of Use of the ELGPN database of initiatives and practices

GENERAL

ELGPN database of LLG related initiatives and practices is a service provided by the European Lifelong Guidance Policy Network. The database includes interesting Lifelong Guidance policy related initiatives and practices from the ELGPN member countries. Finnish Institute for Educational Research reserves the right to the ELGPN database.

PERSONAL DATA

Registration is not needed for information search and no personal data is collected when using the service for search purposes. However, information uploading requires you to be or become a registered user. The registration is needed in order to enable communication between the administrator and the users uploading information (see Register description for information providers). By means of registration the users uploading information in the database can view their own files by logging in their own user account. Information collected from the user uploading information is used restrictedly for purposes of the administration and development of the database. More information concerning the information provided by the users can be found in Information Register Description. If Finnish Institute for Educational Research wishes to use the information in the database for research purposes, permission will be asked from the registered users separately in each case.

RIGHTS AND LIABILITIES OF THE USER

The user accepts the terms of use and to be bound by this agreement. The user bears responsibility for any damage, caused to the offer of the service and shall be liable for any third party claims resulting from such damage which is due to the contact which is not legal, proper nor in accordance with the Terms. The information provider warrants that he/she owns all rights to the content that she/he creates and posts to ELGPN database.

ELGPN permits links to content on ELGPN database. However, the linking should not use ELGPN database content (including personal data of other users) for inappropriate commercial purposes or in any way that is unlawful or harmful to any other person or entity.
