## Report from the Finnish EU presidency conference on lifelong guidance



#### November 2006:

- Since the Communication on Lifelong Learning (2001) and the Resolution on Lifelong Guidance of the EU Council of Education Ministers (2004), much has been achieved in the member-states in improving access to guidance and the quality of guidance systems.
- But much remains to be done. Many countries still have significant gaps in provision and deficits in quality.
- It is important that the momentum of development within memberstates be sustained. The pace and quality of such development can be significantly enhanced by continued collaboration at EU level.
- The structures for such collaboration need to be reframed to build upon past experience and to include more active engagement of all member-states






## Suggested actions at EU level:


- The work of national guidance for acould be significantly strengthened by the establishment of a European Guidance Network
- The aim of the Network should be to improve guidance provision for all European citizens

# **European Lifelong Guidance Policy Network, ELGPN**



- A member state-driven network established 2007
- III Phase 2011-12: 29 members, 2 observers
- ELGPN is a conclusion to meet the challenges the policy makers and European citizens meet in implementing the EU 2020 strategies and the tools supporting the strategy (e.g. EQF,EUROPASS, ECVET, ECTS...)
- ELGPN is supported under the LLP (EU Commission grant covers 75% of the budget)





#### **ELGPN** membership

#### The national partners

- represent a lifelong learning perspective, covering education, training and employment for both young people and adults
- are clearly linked to relevant policy-making processes within their country
- have the capacity both to contribute to the activities of the Network and to involve the relevant national stakeholders in the education, training and employment sectors, including the social partners and guidance practitioners

#### Composition of delegations 2011-12:

•	Educational sector	<b>50</b> delegates from 27 countries

- Employment sector
  22 delegates from 15 countries
- Social sector **3** delegates from 3 countries
- NGOs
  38 delegates from 20 countries



## **EU Council: Invitations to Member States 21.11.2008**



- Encourage the lifelong acquisition of career management skills;
- Facilitate access by all citizens to guidance services;
- Develop the quality assurance of guidance provision;
- Encourage coordination and cooperation among the various national, regional and local stakeholders.
- Use the opportunities provided under the Lifelong Learning Programme and the European Structural Funds, in accordance with Member States' priorities



#### **ELGPN 2007-14**



- I Phase 2007-08
  - Establishment of the infrastructure
- II Phase 2009-10
  - Development of the working methodology and identification of the targets
- III Phase 2011-12
  - Development of tools
- IV Phase 2013-14
  - Impact on national level



## ELGPN as a member state-driven network



- A mechanism to promote structured co-operation between member countries
- A forerunner of the EU 2020 working methodology lifelong guidance as a cross-cutting issue
- A valuable arena for mutual learning
- Strong ownership and commitment among the Network Members

- Increased interaction with national practice and policy development
- Increased interaction between different ministries
- A catalyst for national policy development
- Inspiration for mutual policy learning
- Stimulus for the development of national quality assurance systems
