# PRC activities

- The joint Reflection Notes for all PRCs, following the Tallinn Policy Review Meeting, have been produced by the respective PRC consultants and sent to the Network members on 4 July 2013.
- The summary grid of the progress of country implementation plans, initially developed by PRC3+4, has been revised to cover all participating countries, on the basis of the current entries in the ‘Current phase of development’ section of the Online Work Space.
- Members have been asked to keep the ‘Current phase of development’ section of the Online Work Space up-to-date and to enter the date of the latest update in the appropriate space in the section every time they modify it.

# Translation of publications

- Many countries are translating the ELGPN 2011-12 publications, especially the Resource Kit, into their own languages.
- The country teams can print and/or publish the publications online according to their plans.
- The Co-ordination Unit supports the process by producing the layout of the translated documents. By the end of November 2013, more than ten different language versions of the Resource Kit had been published.

# Production of further Concept Notes

- A topic for a Concept Note is proposed by e.g. a PRC, a country or another group made up of ELGPN members or other relevant actors.
- The ELGPN Steering Group discusses the proposal and approves it, liaising with those who proposed the topic, where appropriate.
- The Co-ordination Unit, in consultation with the Steering Group, contracts a consultant(s) to draft the Concept Note.
- All ELGPN members and representatives of parallel and partner organisations are invited to act as a reference group and to comment on drafts of the Concept Note. If the Concept Note topic has a special link to a PRC, that PRC could act as a core reference group in this process
