## *Youth Guarantee: guidance concepts*

- **Tailoring guidance to individual user's needs**

**Guidance by employment counsellors in PES, municipalities ...**

**Employment counselling including basic career guidance,**

**Orientation**

**Specialist career guidance for educational, vocational orientation**

**Special guidance needs - social inclusion:**

**e.g. case management - multiple problems (social work)  
rehabilitation counselling - disabled**

## *PES to PES Dialogue: Topics and lessons 2013*

- **Peer Review on PES approaches for low-skilled young people and adults**
  - > increasing role of train first approaches for young people
  - > assignment at the discretion of employment counsellors
  - > importance of educational / vocational orientation, partnerships to offer holistic guidance
- **PES to PES Dialogue Conference "Professionalism of employment counsellors"**
  - > striking variety of recruitment requirements and training concepts given similar core tasks
  - > diversity of clients: mix of training and staffing
  - > investments for training are an issue

## *PES to PES Dialogue: Work Programme 2014*

- **Analytical Paper "European competences profile for employment and EURES counsellors"**
  - > guidance for jobseekers and employers
  - > European projects (NICE, Leonardo) ... ELGPN?
- **Peer Review on "PES approaches for sustainable activation of long-term unemployed"**
  - > role of specialist staff and working in partnership (BG)
  - > systematic collection of evidence-based practices
- **Peer Review on "Personalised services for jobseekers in times of digitalization"**
  - > mix of online and face-to-face guidance (NL)



## Guidance in the field of Social inclusion

Adequate social protection and quality social services for all,  
specialised service concepts for special needs  
(e.g. children, homelessness, Roma)

## *Social Investment Package (February 2013)*

- Social protection systems to respond to people's needs throughout their lives, **with a focus on individualised prevention and early intervention -> children-friendly strategies**
  - Greater emphasis on **activating and enabling benefits and services** to enhance people's inclusion in society and the labour market – to be complemented with adequate income support and inclusive labour market measures
  - **Simplified and integrated** benefits and services ('one stop shops') to improve users' access and efficiency
- > different types of guidance services and partnerships

## *Commission proposal for Council Recommendation on Roma Inclusion*

- **Equal treatment and full access for Roma children to quality and mainstream education** and ensuring that all Roma pupils complete at least compulsory education
- **Promoting access to employment** including by guaranteeing equal access to public employment services, and supporting training and skill development
- **Greater social investment** to protect against poverty and exclusion
- Consider making Roma integration an important issue within **national reform programmes** or their **national social reports** in the context of the Europe 2020 Strategy.
