# **Guidance in Ireland: An Overview**

### **Definition of Guidance:**

Holistic definition: Personal & Social, Educational & Career Guidance

Guidance facilitates people throughout their lives to manage their own educational, training, occupational, personal, social, and life choices so that they reach their full potential and contribute to the development of a better society (National Guidance Forum, 2007).

### **Guidance in Ireland: An Overview**

#### **Guidance in Educational Settings:**

- Second Level Schools (12-18 year olds): qualified guidance counsellor, whole school approach
- Further Education settings:
  - Youthreach (15-20 year olds): Advocates, guidance counselling hours, mentoring role of teaching staff
  - Colleges of Further Education (FE programmes):
    qualified guidance counsellor, whole college approach

### **Guidance in Ireland: An Overview**

- Further Education Settings:
  - AEGI Services (40 services): qualified guidance coordinator /guidance counsellor, information officer

Target groups: adults returning to education, back to education programme (level 1-6, NFQ)

• Higher Education: Careers Services in Universities, Colleges, Institutes of Technology: qualified guidance practitioner, information officers

#### **Guidance in the Public Employment Sector:**

- Guidance for adults: in employment & unemployed
- Traditionally FÁS & Local Employment Services (LES)

### **Policy Developments: Education**

#### **Second Level Schools:**

- The Education Act, 1998 (Section 9)
  - A recognised school shall....use its available resources to -

(c) ensure that students have access to appropriate guidance to assist them in their educational and career choices

- Government Policy Decision (2012) changes to funding of guidance
  - Grant more autonomy to school management devolving responsibility locally
  - Standard staffing allocation provision of guidance to students

### **Policy Developments: Education**

### **AEGI:**

- Circular Letters
- Extension of target groups to 16s+ BTEI, Adult Literacy, Community Education

#### Action Plan for SOLAS (Further Education & Training Authority)

- 16 Education and Training Boards (FÁS training centres, VECs)
- Recognition need for guidance provision in FET

### **Policy Developments: Public Employment**

### **Guidance in the Public Employment Sector:**

- FÁS Employment Services function to DSP National Employment & Entitlements Service (NEES) – INTREO (end 2014)
- INTREO single point of contact for all employment & income supports
  - Work placement & job search assistance self service facilities, Case Officers
  - Four One-Stop-Shops (pilot)
