

#### Production of further Concept Notes

- The Steering Group Meeting in Vilnius agreed on the production of two further Concept Notes on the Following topics
  - Early School Leaving and Lifelong Guidance
  - Lifelong Guidance, apprenticeship and other workbased elements of vocational education and training









#### ELGPN response to EASQ open consultation

- During the ELGPN Plenary Meeting on 12-13 December 2013 in Vilnius, ELGPN was invited and subsequently agreed to submit a Position Paper, with suggestions on the role of lifelong guidance in the new context addressed in the consultation.
- ELGPN draft position paper discussed in Athens 19-20 February 2014
- Online consultation on the second draft until 9 April 2014
- Submission to the Commission 15<sup>th</sup> April 2014.
