

## 8<sup>th</sup> Plenary Meeting of ELGPN 22-23 February 2011, Budapest

#### 8th Plenary Meeting of ELGPN was held in Budapest 22-23 February 2011. The total number of the participants was 70 coming from 25 different countries

In the beginning of the meeting the Co-ordinator (University of Jyväskylä), Raimo Vuorinen, warmly welcomed everyone to the meeting after which Ms Katalin Kissné Beneze (Ministry for National Economy) gave a presentation on the Hungarian EU Presidency Programme priorities and their interface with lifelong guidance policy development. After Ms Beneze's presentation, Mr Mark Levin and Ms Natalia Popova (ILO Sub-Regional Office, Budapest) presented the International Labour Organisation's work related to career guidance policies, particularly in relation to low- and middle-income countries.

The third presentation of the day was given by Dr Suzanne Kraatz (DG Employment) and Dr Lucie Davoine (DG Education and Culture). They provided updates on the Europe 2020 flagship initiatives and related lifelong guidance developments.

#### **Networking**

One of the main themes of the meeting was networking on which both Ms. Zsuzsanna Szvetelszky (researcher, University of ELTE, Budapest) and Professor Ronald Sultana (University of Malta) gave a presentation, with particular reference to network building as a tool.

### Development of ELGPN's work methodology and implications for ELGPN governance

In the next session the Co-ordinator reported that 29 member countries had enrolled for the new work programme. New members are Croatia, Ireland and Romania. In addition, two further countries (Belgium and Bulgaria) have observer status. In addition, the Co-ordinator provided information about administration issues (e.g. work programme, dissemination and reporting issues).

The strategic goal of the new work programme was defined as being: to deepen attention to the four themes within the 2008 Resolution; to link this lifelong guidance perspective more closely to sectoral policy development (in schools, VET, higher educaadult education, employment, social inclusion) at both national and EU levels; and

to produce concrete tools to support these processes.

#### **Polish Presidency programme**

In the end of the meeting Ms. Paulina Bogdanska (Vocational Counselling Unit, Labour Market Department, Ministry of Labour and Social Policy, Poland) presented aspects of the Polish Presidency programme which were relevant to lifelong guidance.

The meeting themes were supported by fruitful discussions aiming at deepening networking and sharing information.

#### **Hungarian EU Presidency Conference**

## Adult Learning Action Plan entitled "It's always a good time to learn", 7–9 March 2011 in Budapest

The Hungarian EU 2011 Presidency organised a final conference on the Adult Learning Action Plan entitled "It's always a good time to learn" 7-9 March 2011 in Budapest. Conference web site:

The conference presented the review of the implementation of the Adult Learning Action Plan (2007– 10) and reflected potential actions to enhance policy, practice and participation in adult learning throughout Europe in the period 2011–2020. The agenda of the conference included plenary presentations and discussions in thematic working groups. Among the national delegations the following ELGPN representatives were participating the conference: Concetta Fonzo (IT), Craciela Sbertoli (NO), Tibor Bors Borbely (HU),Dimitris Kullis (LV), Jennifer McKenzie (IR), Heike Manschner (DE) and Raimo Vuorinen (FI).

In the keynote presentation Ms. Maria Joao Rodriques (PT) emphasized guidance as the first priority in the development of adult education in Europe 2011-2020. She stressed that guidance is a crucial element in supporting the European citizens in customizing their individual learning journeys and tailor made careers. In addition to the development of individual career management skills she noted that there is also a need to mobilize different financial instruments to support favorable conditions to adult learning.

One of the working groups focused on increasing participation in adult learning and the role of outreached activities and guidance. The meeting was chaired by the ELGPN Co-ordinator and Ms. Jennifer McKenzie acted as the rapporteur of the workshop.

The discussions highlighted the recent lifelong guidance development in EU and recommendations from related Peer Learning Activities. The background document addressed also questions for consideration for the conference participants. The working group identified the fragmented services as a common challenge and proposed actions to improve the situation as follows:

- There is a need for a common conceptual framework for adult learning and guidance
- Within European level there is a need for stronger co-operation with adult learning organisations and other lifelong learning networks e.g.
- o In the forthcoming EU programmes there is a need on incorporate capacity building elements in addition to operational level projects
- In order to meet the increased demand of guidance there is a need to promote more diverse LLG delivery modes, e.g. outreached services.

The concluding plenary discussions from all the seven working groups proposed a number of priority themes in enhancing adult learning in accordance to EU 2020 priorities (Flash Report Budapest Conference 7-9 March 2011):

- Helping the low skilled and low educated acquire the key competences for life and work, starting with basic skills - adequate literacy, numeracy and digital skills;
- A sophisticated **guidance service** to ensure that adults make the right choices, find the right offers and design a lifelong project for themselves;
- Tailor-made responses to the individual learner's needs, supported by a range of pedagogies combined with ICTs, and supported by highly competent teachers to guide them in the knowledge society where everyone should make the best of their abilities;
- Learning centres/ learning communities and regions, with a strong link to social networks, which should give adult learning a more important place in the community, with robust partnerships across all relevant local actors supporting the central role of the public sector;
- Vital contribution of higher education institutions which have the dual role of opening up to adult students and providing research and analysis of the sector;
- Developing a greatly improved knowledge base on adult learning sector;
- Improving professional development in order to ensure and maintain the high quality of teaching staff in the adult learning sector;
- A vibrant new sector, "learning for a long life", and for active, autonomous, and healthy ageing, which cultivates inter-generational learning and solidarity between ages, and using the social, cultural and identity capitals of older people, in addition to their human capital.
